HOW CAN I APPLY?



Conditions

- Being part of the eligible regions
- The beneficiaries must be public organisations, organisations under public law, private non-profit entities, for-profit entity and/or companies
- Large companies (>250 employees) cannot participate in the programme
- At least 3 partners from at least 3 different countries participating in the programme
- Application form presented in all the languages of the partnership (except the calendar, financial plan and budget justification)
- The lead partner cannot be a private for-profit body and/or company



Pre-requisites

- Demonstrate the relevance of the transnational approach
- Chain value: All the actors required in order to have a concrete impact on the territory must be included in the project
- The project must match at least one realisation indicator
- The project has to be easily transferable (replicable on another territory) and sustainable (the end of the project does not mean the end of the results)

Expected characteristics 3a1: Development of capacities and improvement business environment in the Sudoe area

- Digital Information: Collect and treatment of Data to improve decision-making (Big-Data)
- Digital Innovation: Define business strategies and methodologies in order to stimulate digital innovation
- Strengthening digital research and innovation for companies
- Connectivity technologies all along the chain value for more efficiency (Industry 4.0)

Axis 2: Competitiveness of SMEs (8.4 million euros)

Expected characteristics 3b1: Improvement and increase of internationalization opportunities for SMEs

- The project must be a tool, a system or mechanism that can be used to promote businesses internationalization. It can be a mobile app, a platform or a methodology at the free disposal of companies in the Sudoe area

Sectors covered: Aerospace and aviation industry, water resources, environmental services, automobile industry, tourism, biotechnologies and health, textile industry, agribusinesses and wood industry, creative industries, industrial technologies, ICTs

Type of actors:

The project must include at least 1 organism that belongs to the following categories:

- Public institutions competent in the internationalization of within regions
- business clusters/business parks, industry associations

Only projects corresponding with the characteristics described in the call will be funded



Axis 3: Low-carbon Economy (7.3 million euros)

Expected characteristics 4c1: *Improve policies in the field of power efficiency for public buildings and housing thanks to networking and joint experimentation*

- Candidatures must include a proposition of design, as well as the validation and implementation of a power-efficiency model that brings new forms of management and use of new materials for energy saving in public buildings and housing.

Type of actors:

The project must include at least 1 organism that belongs to the following categories:

- Public organisations in charge of the improving energy efficiency
- Professional organisations and/or energy agency
- Organisations with competences and technical knowledge in the field (Universities, technology centres, companies working in this field)

Only projects corresponding with the characteristics described in the call will be funded



Axis 4: Combating Climate Change (7.2 million euros)

Expected characteristics 5b1: Improvement of coordination and efficiency for the prevention and management of disasters as well as the rehabilitation of disaster-stricken areas.

Type of projects:

- Projects must tackle one of these 2 lines of intervention
- Projects must establish a plan or a prevention strategy for risks, emergency plans, fast intervention plans, intervention protocols, fast alert systems, geographic information systems, accident simulators, action and prevention plans
- Projects can capitalize on innovative practices regarding risk management already implemented by other projects along the previous frameworks

Type of risks targeted:

All the risks that are common to the Sudoe area such as droughts, desertification, soil erosion, wildfires, floods or cyclical submersions. Technological risks are also considered a growing threat.

Type of actors:

- Competent public organisations: national, regional and local authorities, agencies for development, environmental services, units specialized in risk management, units in charge of urban planning and territory planning, meteorology institutes, natural parks, civil protection authorities demonstrable on the risk chosen (universities, clusters...)

To provide via eSudoe (online platform):

- the application (written in the languages of the beneficiaries involved in the project)
- The Commitment and Responsible Statement (in the language of the lead beneficiary)
- The declaration of interest of each beneficiary in his or her own language.

NB: the Commitment and Responsible Statement should be sent to the Joint Secretariat, in paper format, duly signed and stamped by the legal representative of the lead beneficiary's entity, by mailing post on the 21st of September of 2018, at the latest (attested by the postmark).



2ND STAGE - MARCH/MAY 2019

After a first selection process, the projects authorized to apply for this phase will have to provide the following documents via eSudoe (online platform):

- the complete application form (application form, financial plan, justification of the financial plan and schedule of the project), the Commitment and Responsible Statement of the lead beneficiary (specific to the second stage)
- the following appendices : the collaboration agreement between beneficiaries, the declarations of VAT regime for each beneficiaries, the convention or equivalent document (if, exceptionally, the resort to a third-party entity is proposed), the budgetary commitment for each beneficiaries, and, in case entities join the 2nd phase, a declaration of interest

NB: the Commitment and Responsible Statement of the lead beneficiary will have to be sent in paper format to the Joint Secretariat.

WRITING TIPS

Do's

- Get acquainted with the text of the call
- Use SMART objectives (Specific, Measurable, Achievable & Acceptable, Realistic, Time-bound)
- Your project must give a solution to an identified problem
- Demonstrate the coherence of adopting a transnational approach of the problem you want to solve
- Demonstrate the added value of transnationality

Dont's

- Try to make your idea enter in the "labels" instead of starting from the call and adapt your idea
- Your realization does not contribute to any of the programme's indicators (See part fact 3.1; programme manual)
- Neglect the communication aspect
- Forget about the horizontal principles (sustainable development, equal opportunity and non-discrimination, gender equality)
- NB: If your project goes to 2nd phase, do not forget to get your budget validated by GAI!

USEFUL VOCABULARY

RESULTS

Direct effects resulting from the project and the production of its outputs. They represent what the project aims to change. It can be the organization of interregional events, the identification and dissemination of good practices, the production of policy recommendations are merely means to achieving the results of the project. Unlike outputs, they imply a qualitative value, an improvement compared with an initial situation. They have to be measurable in physical units, such as the number of policy instruments influenced.

OUTPUTS

Tangible deliverables of the project which contribute to the results. They directly derive from the activities carried out in the project. They do not lead to a qualitative judgement on the project's results. In other words, it is not because the project organizes a high number of workshops (output) that it will necessarily be successful. Outputs are typically measured in physical units, such as the number of seminars, site visits, conferences, participants, publications, good practices identified, or policies addressed.

GOOD PRACTICES

consist in sharing your experience with your partners in order to find the best way to deal with a common issue or challenge.

REALISATIONS

It is the produce of the co-financed activities. They reflect what has been realized in adequacy with the budget allotted to the project. It can be measured thanks to the realization indicators of the programme and they contribute directly to reach the results of the project.
